Challenges With Manual User Provisioning & User Access Reviews

User provisioning and de-provisioning involve various manual processes, including bulk user account creation, making changes in Active Directory, and managing access to self-service and other relevant applications like Salesforce, etc. It also includes revoking users' access when they leave the organization. All these tasks of creating new accounts and assigning the right access can be time-consuming and cumbersome, especially when the volume of data is high. It often leads to employees being unproductive if there is a delay.

Manually performing user access review usually involves email communications asking managers to approve or reject access for their employees. Many companies use spreadsheets, SQL reporting, and laborious manual cross-checking procedures. 
